

TERMS & CONDITIOS

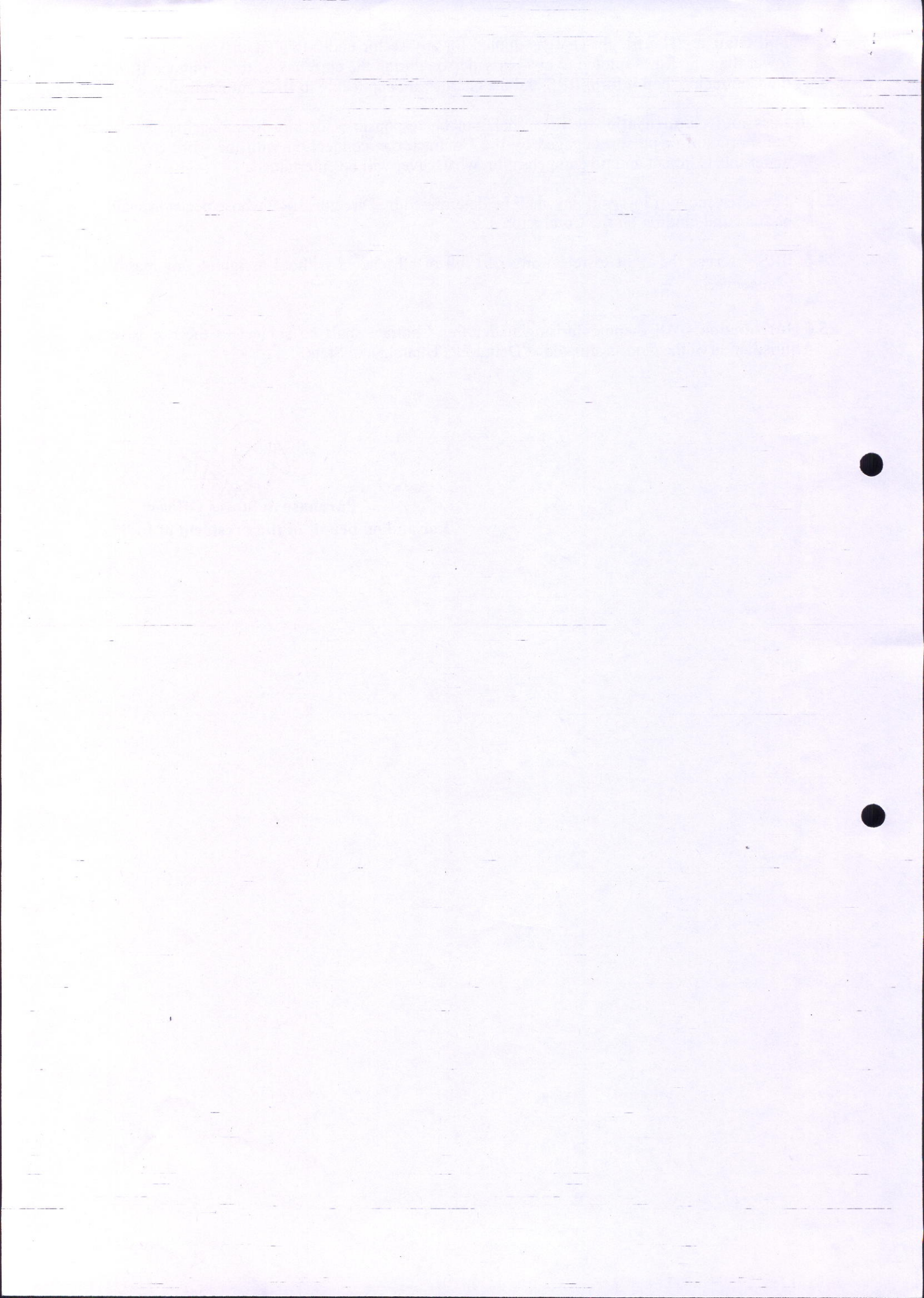
- 1.0 **Period of Contract:** This Rate contract shall be valid for a period of one year. However, IIRS reserves the right to extend the contract for a further periods on mutual agreement or short close the same by giving one month prior notice in writing without any financial obligation on either side
- 2.0 For Incoming goods, Trucks are to be supplied to our clearing agent on demand. Failure to supply trucks may lead you to pay all demurrages incurred in this regard. For sending material to our site, Truck is to be supplied to our representative.
- 3.0 For all outgoing consignments, i.e. from IIRS to various destination, the delivery of the goods has to be taken from IIRS, Dehradun and also from our nearby supplier or contractor and to be delivered on door delivery basis to consignee.
- 4.0 The transportation of consignments shall be on door collection and door delivery basis. Loading and unloading will be the responsibility of the consignor/consignee.
- 5.0 **Safety-** The material/equipment entrusted for transportation to the contractor are normally high value sophisticated and intended for time bound Projects of National importance. The contractor should ensure safe transportation of the consignment with utmost care. Transshipment of the consignment en-route is not permitted.
- 6.0 The consignments handed over to you need not be insured unless otherwise asked to do so and no additional payment shall be claimed or reimbursed on this account.
- 7.0 The goods shall be transported under Carrier's risk only. Any loss or damage caused to the Government Goods during transportation and handling shall be compensated by the Carriers to IIRS subject to force majeure condition. However the Contractor will continue to be liable for pilferage, theft, damages and non-delivery.
- 8.0 The materials transported should be delivered to the destinations within a reasonable period and the transit period should be to the minimum.
- 9.0 **Documentation:-** Upon receipt of the intimation for transportation, the contractor while collecting the consignment, should prepare a **Clear Lorry Receipt** with full details such as Brief Description, dimension of the consignment, no. of articles, marks, type of vehicle used with Registration number etc.

- 10.0 The transportation contract also intends for the transportation of Consignments arrived at various Sea port/Airport and in case of any delay in placing the vehicle resulting in payment additional wharf age/demurrage charges, such charges will be recovered from the contractor.
- 11.0 The Vehicles provided for transportation shall be road worthy and in good running condition having valid National Permit. The vehicle provided shall have required documents such as RC Book, Insurance, valid fitness certificate, tax paid up to date and the driver should possess valid driving license to drive appropriate class of vehicles. The contractor is also responsible for obtaining clearance for over dimensional consignments from the Road Transport authorities of the concerned States, wherever necessary.
- 12.0 The consignment entrusted for transportation shall be secured properly by lashing, wedging (slashing) using 'D' shackle etc., properly anchored using steel wire ropes and should be arrested to prevent movement during transportation and should be covered properly.
- 13.0 The truck provided for transportation shall be exclusively used for IIRS materials and no other materials shall be loaded in the Truck.
- 14.0 Wherever Consignor/Consignee intends to depute an escort for important consignments; he shall be loaded in the Truck.
- 15.0 **Payment :-** Payment for the transportation shall be arranged within 30 days from the date of receipt of your bills in triplicate, duly supported by all relevant documents such as instructions for transportation issued by the consignor indicating details of the materials and the type of vehicles required, acknowledgement obtained from the consignee duly countersigned by the authorized Officer for having received the consignment in sound condition . The acknowledgement obtained from the consignee shall also indicate the weight of the consignment received and the type of vehicle with Regn. No. through which the consignment delivered. Income Tax applicable shall be deducted from your Bill.
- 16.0 The contractor shall not sublet, transfer or assign the Contract or any part thereof to any other agency without prior written approval.
- 17.0 IIRS reserves the right to award the contract to one or more parties or enter into parallel or Adhoc Contract or simultaneously with one or more parties during the currency of the contract.
- 18.0 If the Contractor fails to carry out the transportation work within the time limit stipulated, IIRS, reserves the right to get the transportation work carried out through any other transporter and any additional expenditure that may be incurred in this connection over and above what would have been payable to the carrier had the carrier been engaged under the terms of this Contract, shall be recovered from the Contractor without prejudice to any opportunity cost in addition to the freight.
- 19.0 **Arbitration: -** All disputes, differences, claims and demands arising under or pursuant to this agreement shall be referred to Arbitration of a Sole Arbitrator to be appointed by Director, IIRS. Arbitration shall be held in Dehradun and shall be Subject to and governed by the provisions of the Arbitration and Conciliation Act.
- 20.0 **Local Levies :-** Being Government of India Department, we have been exempted from the payment of Octroi and similar local levies and necessary Exemption Certificates required en-route should be collected from the loading points and carried during transportation. If any payments are made by the transport contractor, the department will not be responsible for such payments and no detention charges of the vehicle on this account will be entertained.

- 21.0 **Fall Clause:-** The freight charges quoted for any sector under this enquiry should not be lower than the Rates quoted to any party/person during the currency of this Contract. If so, the Contractor shall inform IIRS and the charges are applicable to IIRS automatically.
- 22.0 **Loss and compensation :-** IIRS shall not be responsible for any loss sustained to the transportation or person engaged by the Contractor in connection with the work covered under this Contract and no compensation whatsoever will be entertained.
- 23.0 The assessment of losses if any shall be determined by Director, IIRS whose decision shall be final and binding on the Contractor.
- 24.0 IIRS reserves the right to reject any part/full or all tenders without assigning any reason whatsoever.
- 25.0 **Jurisdiction:-** All disputes arising under this Contract shall be subject to the exclusive jurisdiction of the Courts situated at Dehradun, Uttarakhand State.

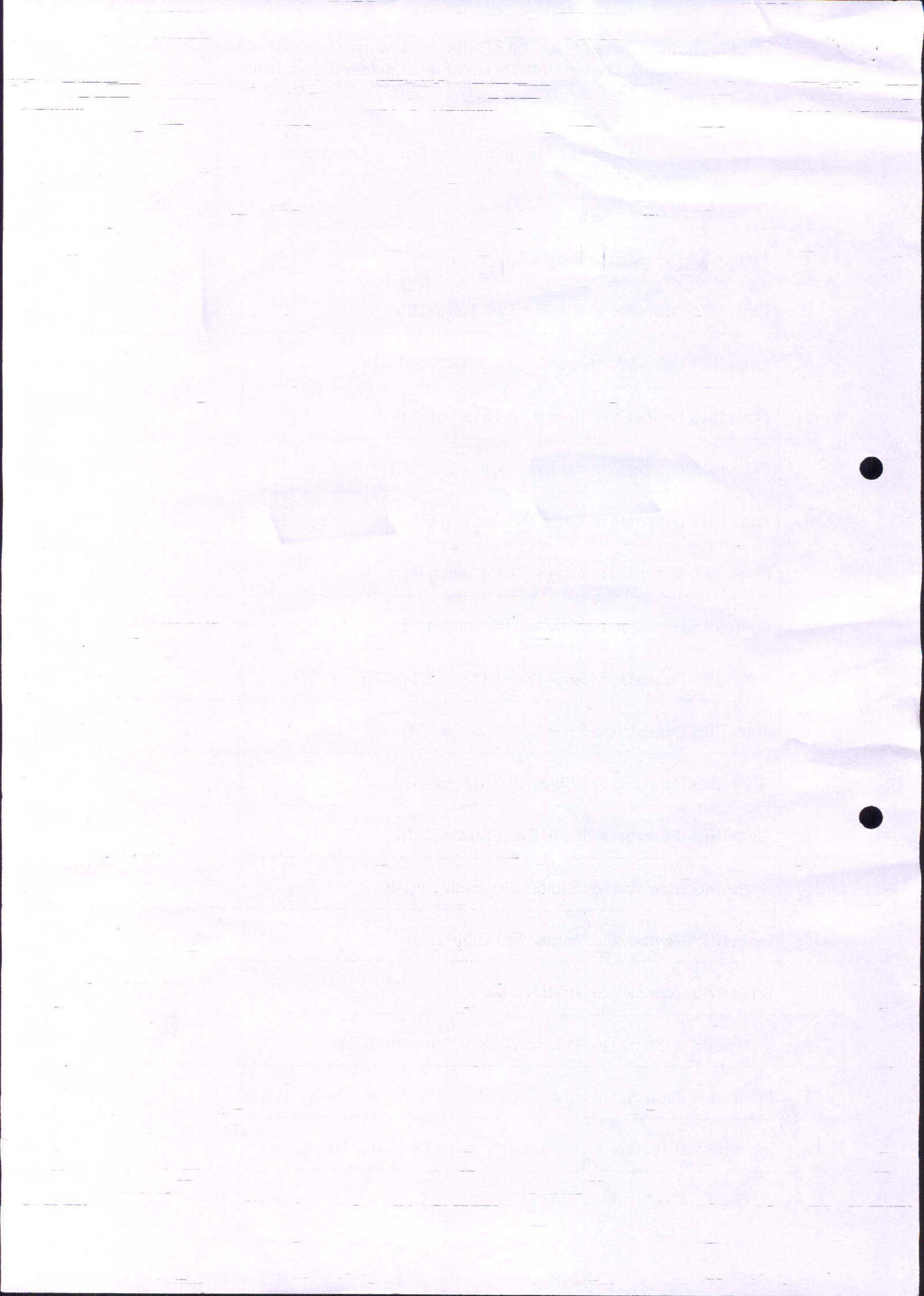
